

# CSR 50<sup>th</sup> Anniversary Celebration Campaign

## Dr. Curtis E. Patterson Provisional Troop Campsite



- The purpose of the Cherokee Scout Reservation 50<sup>th</sup> Anniversary Celebration Campaign is to raise \$25,000
- The capital funds raised will go towards improvements in the Provisional Troop campsite
- The Provisional Unit campsite will be named in memory of Dr. Curtis E. Patterson – a longtime volunteer camp staff member who served as the assistant provisional Scoutmaster
- The improvements to the campsite include building 5 Adirondacks that will house 4 campers each; upgrading the existing shelter with electrical outlets, LED lights, and ceiling fans; and a permanent campsite gateway
- The campaign will run from May 2018 to March 2019
- The goal is to raise funds by March 2019 so the improvements can be in place by Summer 2019
- We will host a dedication ceremony in Summer 2019
- To secure naming rights to a structure a minimum of a third of the gift must be deposited.
- We request legacy Friends of Scouting donors make their FOS gift first, then consider a second gift to the CSR 50<sup>th</sup> Anniversary Celebration Campaign
